Professional Photographers of South Carolina CODE OF ETHICS

The corporate Charter of
The Professional Photographers of South Carolina, Inc. states as its general purpose the following:

The promotion of one of the fine arts and the support and encouragement of the art of photography, namely, and to advance photography in all of its branches, both as an art and as a profession; to create, foster, promote, and maintain cordial relations and cooperation and interchange of thought and opinion freely among its members; to oppose violation and infringements of the rights of professional photographers of their organizations; to foster the practical benefits to be derived from personal acquaintance and the discussion of subjects having to do with the art or profession of photography; to cooperate with other organizations which may be striving to accomplish similar purposes.

- I understand and accept the purpose of this association, and agree to abide by and support the conditions set forth within this association's corporate purpose.
- I will cooperate whenever possible with other members of this association and assist whenever possible should they be in trouble or difficulty.
- I will share knowledge with the other members and try myself as well as encourage other members individually and collectively to achieve and maintain the highest standards of quality.
- I will, at all times, avoid the use of unfair competitive practices as determined by any court of competent jurisdiction, the Federal antitrust laws and related statutes.
- I recognize the authority of this association in all matters relating to the interpretation of this code in accordance with the statutes of the United States and the State of South Carolina and the decisions of courts and governmental agencies of competent jurisdiction.

Terms of Membership

Payments to the Professional Photographers of South Carolina, Inc. are not deductible as charitable contributions for Income Tax purposes. Payments may be deductible as an ordinary and necessary business expense if you are in a photography related business. Please consult your own tax advisor. Submission of this application indicates your agreement to follow and abide by the policies and procedures and the Code of Ethics of the Professional Photographers of South Carolina. Membership commences upon receipt of payment, approval by the PPofSC Board of Directors and is for one year. Dues subject to change.

Information for Full Payment or Quarterly Credit Card Option Applicants: By submitting a quarterly credit card option application, I understand that PPofSC will charge my credit card in one full payment or quarterly. Depending on which option was chosen. I understand that I will pay an additional \$2.00 per quarter for bank processing fees included in the dues amounts in this application for quarterly charges. The quarterly charge will appear on my credit card statements as the Professional Photographers of South Carolina and the statement will act as a receipt. PPofSC will notify me of any dues or membership changes and will automatically renew my membership. I can at any time resign from PPofSC and stop charges being made to my credit card. Any payments made prior to that are nonrefundable. A resignation must be received in writing, fax or e-mail. E-mailed resignation must come from the e-mail address contained in the member's record and include their name.

By checking here, I elect not to have the PPofSC automatically renew my membership.

I agree to inform PPofSC of any changes made to my credit card, such as a change in any account number. If PPofSC is unable to successfully make a charge to my credit card, PPofSC will contact me to make any changes or corrections to my record. If PPofSC is unable to successfully process my full/quarterly payment, my membership will be considered void, and I am required to pay the balance in full to reinstate my membership. PPofSC is not responsible for any overdraft or bank fee charged to the member if a debit card is used for membership dues payments.
